The Crèdit Andorrà Group, leader in the Andorran financial system, extends its presence in the Spanish insurance market with the opening of CA Life Insurance Experts, after obtaining the necessary authorisations from the General Directorate of Insurance and Pension Funds (DGSFP) in Spain and the Andorran National Institute of Finance (INAF) in Andorra. The new entity will centre its activity in the insurance of life risk and savings, and will offer its clients a personalised service and advice.

The operation represents another step forward for the Group in its strategy of internationalisation, which has led to its presence already in Spain with the holding company ERM and with Banco Alcalá. The CEO of Crèdit Andorrà Group, Josep Peralba, explained that "in Andorra, the Crèdit Andorrà Group is strong in the life assurance market due to the professionalism and experience of the company Crèdit Assegurances. This high degree of knowledge of the business and the market is what enables us now to deploy our services in Spain, benefiting from the Group's structures and solvency".

CA Life Insurance Experts has two offices in Spain, in Madrid and Barcelona.

The activity of insurer is centred on the marketing of life risk and savings insurance, for example, the Assured Prevision Plan (APP) and Individual Systematic Savings Plan (ISSP), with the objective of offering guaranteed net returns.

The Crèdit Andorrà Group entered the Spanish insurer market with the holding company ERM, which offers comprehensive risk management. Currently the holding company is installed in Barcelona, Girona, Tarragona, Lleida, Madrid, Seville and Palma de Mallorca.

In the Spanish financial market, the Crèdit Andorrà Group operates through its private banking subsidiary Banco Alcalá, an entity directed to global asset management for private and institutional clients, typified by excellence in commercial relationships and by offering a service totally made to measure for each client. The entity is part of the Crèdit Andorrà Group's European private banking project, together with Banque de Patrimoines Privés in Luxembourg. The offer of differential value of this project in European private banking is typified by offering personalised service, a global offer, comprehensive advice and open architecture for advice on the product.

Crèdit Andorrà is the leading financial group in Andorra in equity, assets under management, business volume, loan investment and profits. The entity manages a business volume of 14,410 million euro (2012).

Crèdit Andorrà gives services in commercial banking and private banking, which are supplemented with other business lines offered by the Group, such as insurance and asset management on an international scale. Crèdit Andorrà is in a process of expansion which has led to its presence in ten countries: Andorra, Spain, Luxembourg, Switzerland, United States (Miami), Mexico, Panama, Paraguay, Peru and Uruguay.

The international agency Fitch Ratings has awarded Crèdit Andorrà a long-term rating of Aand a short-term F2, ratings maintained in the last review in June 2012, particularly significant in view of the current international economic and financial situation.

The bank has been named seven times as Bank of the Year in Andorra, by the financial publication *The Banker* of the Financial Times group (2002, 2003, 2004, 2006, 2007, 2008 and 2010).

Crèdit Andorrà has been classified in position 757 on a world scale and holds first position among Andorran banks in the Top 1000 ranking prepared every year by *The Banker* (edition July 2012). This ranking classifies banks according to their strength and capitalisation.
